## Fees in Lieu of Taxes

Chief Kytta updated the Board on the progress of "Fees in Lieu of Taxes". Chief reported that the contract with Lewis County that covered Schaeffer Park, SWW Fairgrounds and the Big Hanaford Rd shop has not been renewed for several years. He informed the Board that the contract has been sent to the County for review and renewal. Chief Kytta also proposed to Centralia School District a \$1.00 per student (enrollment as of November 1, 2014) fee for our services. If the school district accepts our proposal, it will make it easier to address other non-profit organizations.

#### EMS Dispatch Modifications

Chief Kytta updated the Board on the modifications that have gone into effect as of December 22, 2014. He stated that so far, all is going well and will continue to be monitored.

## Labor Management Update

Chief Kytta stated that this is a contract negotiating year. Labor Management met a week ago to start talks regarding negotiations. At this time negotiations will consist of Chief Kytta and Chief Mack on the management side. Chief Kytta asked if any of the Commissioners would be interested in serving on the management side of the table. Commissioner Johnson will be the primary with Chair Coumbs and Commissioner Thompson as alternates.

#### New Business

### a. Lewis County Radio Services Agreement

Chief Kytta reviewed the proposed inter-local agreement from Lewis County to provide backup maintenance and repair on our 2-way radio system. Day Wireless is our main vendor for maintenance. Commissioner Johnson made a motion to accept the proposed agreement. Commissioner Thompson seconded. Motion passed 5-0

## b. Chehalis / Lewis County District #6 Automatic Aid Agreement

Chief Kytta discussed the updated Automatic Aid Agreement with the City of Chehalis and Lewis County Fire District #6. Commissioner Davidson made a motion<sup>2</sup> to accept the proposed renewal contract. Commissioner Johnson seconded. Motion passed 5-0

### c. Draft EMS Levy Ballot title/Resolution #15-01

Chief Kytta discussed the certified numbers that came back from the county. No prorationing occurred for the RFA and the M & O Levy came in at \$0.44/per thousand. The next hurdle is to renew the 6 year EMS levy. Chief Kytta's goal is to have it on the April ballot. Chief Kytta went over the proposed language for the ballot and also discussed what kind of information to distribute to the community. He also stated he would like to see the Board active in this levy. Commissioner Johnson made a motion<sup>3</sup> to instruct the Board Secretary to forward the draft ballot title and resolution to Lewis County for review and comment. Commissioner Thompson seconded. Motion passed 5-0

#### d. Forest Land Response Agreement w/DNR

Chief Kytta discussed the proposed response agreement with the Dept. of Natural Resources. Commissioner Johnson made a motion to approve the fire response agreement with the Washington State Department of Natural Resources. Commissioner Canaday seconded. Motion passed 5-0

## e. Policy #228 - Promotions

Chief Kytta reviewed the proposed policy. Currently, the RFA does not have a policy addressing promotions for the volunteers. The collective bargaining agreement addresses promotions and promotional testing. Commissioner Canaday made a motion<sup>5</sup> to approve and implement policy #228. Commissioner Johnson seconded. Motion passed 5-0

### f. Resolution #15-02; Surplus Property

Chief Kytta discussed the list of surplus items that need to be sold or disposed. Chair Coumbs read Resolution #15-02 aloud. Commissioner Johnson made a motion<sup>6</sup> to approve the list of surplus items. Commissioner Thompson seconded. Motion passed 5-0

## g. Small Works Roster

Chief Kytta stated that we have had an agreement with the City of Centralia for the past 4 years authorizing the use of their small works roster. The current agreement will expire in February of this year. Commissioner Johnson made a motion<sup>7</sup> to approve the agreement with the City of Centralia and authorize the Fire Chief to execute the contract on behalf of Riverside Fire Authority Commissioner Canaday seconded. ### h. Community Risk Reduction

Chief Mack discussed what "Community Risks" are and how to recognize them. His goal is to find ways to reduce those incident numbers that are risks through Fire Prevention and other incidents that happen in the home. He shared the possibility that the RFA may benefit from a grant that would provide an allotment of smoke alarms.

i. <u>Hold Harmless Agreement with the City of Chehalis concerning FF/PM Penny McCarty</u> Chief Kytta reviewed a proposed agreement that would allow Chehalis FF/PM Penny McCarty to work one shift per month at the RFA to retain her paramedic certification. Chehalis does not possess the equipment or state license required to provide paramedic services. Commissioner Canaday made a motion<sup>8</sup> to approve the agreement with the City of Chehalis. Commissioner Johnson seconded. Motion passed 5-0

## j. Washington State Rating Bureau

Chief Mack gave an update that the number of volunteers and equipment placement at Station 8 has been met to satisfy the rating bureau. Mr. Cunningham, with the rating bureau, has sent a report to Chief Mack stating we have met all requirements. Chief Mack will share the report with the Board when he receives it.
