Old Business

Master Planning Update; Section 9 Human Resources

Motion passed 5-0.

New Business

Lewis County Investment Pool Agreement

The RFA received correspondence from the Lewis County Treasurer's office that they are implementing a local investment pool to allow for a mix of investment maturities resulting in better yield while maintaining a sufficient liquidity to meet cash flow needs. Chief Kytta sent this agreement off to legal counsel for their approval. Council will be sending their recommendation within the next few days. If approved by council, staff is asking for the approval from the board for Chief Kytta to execute the agreement with Lewis County. This item will be brought back to the board at the next meeting.

1st Quarter 2022 Incident Report

Chief Kytta reviewed with the board the first quarter of 2022 incident reports. Discussion followed.

RFA / City of Centralia Representative Group

Commissioner Dolezal stated he had conversations with the City of Centralia Mayor and the City of Centralia Manager regarding putting together a representative group to provide communication within the two entities.
