RECITALS

- A. The undersigned Riverside Fire Authority is the grantee of this permanent easement for a communication site of 1.63 acres, including access and power to the site in Lewis County, Washington described on Exhibit A and shown on Exhibit B (Easement).
- B. The Easement was granted by Rayonier Timber Company to Riverside Fire Authority on February 9, 2005 and filed and recorded in Lewis County under file number 3215975 on February 14, 2005.
- C. The State of Washington acting by and through the Department of Natural Resources (State) acquired the property from Rayonier Forest Resources, L.P. February 9, 2009 and filed and recorded in Lewis County under file number 3338294 on December 04, 2009.
- D. US Cellular (d/b/a McDaniel Cellular Telephone Company, Communication Site Lease #52-091173) desires to construct and operate a communication site on State managed land using the same road access as Riverside Fire Authority and to have power provided by the Lewis County Public Utility District (Lewis PUD).
- E. Lewis PUD has applied for a utility easement across the same Easement location used for power by Riverside Fire Authority to provide power to Riverside Fire Authority and US Cellular.

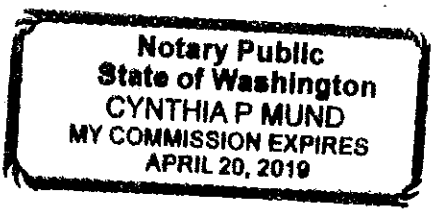
